Course description

Start on Blackstone Edge Old Road SD 944166; finish at the top of Blackstone Edge Old Road SD 958168, approx. 2 km

Traffic flows

Minor road through residential area on lower part and no significant junctions.

Course event/history

This is a Type A (Open) events course already in use by Manchester CTT and designated J 9-19. The risk assessment has been transferred to the standard format used by CTT North District and the requirements are consistent.

6		Finish at the top of Blackstone Edge Old Road SD 958168	Riders finishing	LOW	Organiser to position CYCLE EVENT warning sign to make riders aware of cycle event, ensure officials wear high visibility jackets/bibs and position 1 marshal for safety.
7		After the finish	Riders returning to HQ	LOW	Organiser to remind riders to obey rules of the road in start sheet and advise of best route to HQ.

NOTES:

- 1. The use of a vehicle for the timekeeper(s) at start and finish is where appropriate and is only identified as an example for the action to be taken.
- 2. The small junctions or entrances to farms/ facilities (garage, eatery, etc) that are not identified in this risk assessment have been considered, however are not considered significant to pose a risk and therefore have not been noted.
- 3. All rules of the road must be followed as to 'the Highway Code'.
