Changes following the National Council Annual General Meeting 2015

Adoption of new Articles of Association

The existing Articles of Association of Cycling Time Trials (and the provisions of the Memorandum of Association) have now been deleted in their entirety and replaced with completely new Articles of Association. A copy of the new Articles of Association has now been registered at Companies House. A copy will be included in the 2016 CTT handbook and will also be available for inspection on the CTT website.

Prior to the National Council AGM a copy of the proposed new Articles of Association was sent to all clubs affiliated to CTT. The Articles of Association were further amended at the AGM to include reference to Scotland and the wording of Article 3.1(a) now reads:

"To control unpaced cycling time trials and such other cycling events as the Company shall from time to time decide, held on the public roads, private roads, tracks, circuits and off road courses of any nature whatsoever, of England, Wales, the Isle of Man, the Channel Islands and Scotland...".

The Board of CTT would like to thank all District Officials for their help and patience whilst this difficult exercise was carried out.

Chairman:

Sheila Hardy, Midland DC, was re-elected as Chairman for an eighth term. In accordance with the new Articles of Association, Sheila will now serve as Chairman for a term of three years until the National Council AGM in 2018.

At the National Council AGM 2018 the Chairman shall retire by from office although shall be eligible for re-election. The chairman then elected (or re-elected) shall serve as Chairman for a term of three years.

The Board of Directors:

In accordance with the new Articles of Association directors will now retire by rotation so no director will serve for a period of more than three years without standing for re-election.

Changes to Rules and Regulations

(Page numbers refer to the page numbers of the 2015 CTT handbook)

Closing Dates for Entries

RTTC National Championships – Events, Awards and Competitor Conditions Condition 2(e) (page 221)

Insert at the beginning of the first sentence the words, "Unless otherwise varied" and add a new sentence at the end of Condition 2(e) as follows:

"Any variance to this must be approved by the Board of Cycling Time Trials and clearly shown in the handbook entry" so it reads:

"Unless otherwise varied the **closing date for entries** shall be not later than the Tuesday 19 days prior to the Hill Climb, and 25/26 days prior to the event in the case of all other

Championships. Any variance to this must be approved by the Board of Cycling Time Trials and clearly shown in the handbook entry."

Standard Closing Dates

(page 113)

In paragraph (1) delete "at 6 pm" and replace with "at 23.59" so it reads:

"(1) Entries for all events held on a Friday, Saturday, Sunday or Monday, close at 23.59 on the Tuesday 10 to 13 days prior to the holding of the event."; and

In paragraph (2) delete "at 6 pm" and replace with "at 23.59", and change the word "closing" to "close", so it reads:

"(1) Entries for all events held on a Tuesday, Wednesday or Thursday, close at 23.59 on the Saturday 11 to 13 days prior to the holding of the event."

Gender Categories

Regulation 10, page 325

Delete Regulation 10 in its entirety and replace with:

"Where awards are exclusive to one gender, athletes must ride in the category relating to their gender at birth. Notwithstanding the above, athletes who wish to compete in events for a category that differs from their gender at birth must apply to the Cycling Time Trials Board for permission to do so.

Cycling Time Trials adopts the policy framework as recommended by the Sports Council Equality Group ("SCEG") for non-contact sports.

The Cycling Time Trials Board shall be entitled to appoint a medical expert to consider, in complete confidence, each individual case and to make recommendations to the Board. The athlete will be responsible for the provision of all requested medical evidence and will be responsible for all the costs incurred by the Company in dealing with the application.

The applicant must agree to:

- a) Provide medical proof of gender reassignment
- b) If requested submit to a physical examination by a doctor appointed on behalf of the Company.
- c) Permit discussion between the athlete's doctor(s) and the medical expert examining the case appointed on behalf of the Company.
- d) Confirm that the gender reassignment is permanent and that they are not dependent on the use of substances banned under the anti-doping regulations.
- e) If required, to submit to an anti-doping control test.
- f) If requested to do so by the Company, provide periodic updates relating to their gender reassignment treatment."

Regulation 27(j)(xi) (page 332)

Add a fifth bullet point as follows:

"electronically in an appropriate format to results@cyclingtimetrials.org.uk "

Standing Order 7

In accordance the Board's powers under Article 33.2(i), the existing Standing Order 7 (page 77 of the 2015 CTT handbook) has been deleted in its entirety and replaced with the following:

A Quorum

For District Council meetings a quorum shall consist of delegates from not less than five of the clubs eligible to be represented. If a quorum is not present within 10 minutes of the time appointed for holding such a meeting the Chairman shall have the power to proceed as if a quorum were present.

For District Committee meetings a quorum shall consist of not less than five of the members of the District Committee. If a quorum is not present within 10 minutes of the time appointed for holding such a meeting the Chairman shall have the power to proceed as if a quorum were present.

From the CTT Treasurer - Mark Sanders

At a Board meeting on 9 August 2015 it was agreed that District Treasurers' should hold bank accounts in the name of CTT. I know for most of you this will not change your arrangements and it is only a minority that will be affected. At this stage I am not suggesting that you open a business account, but at least have an account with CTT and the District in the name. I believe that as a limited company this is appropriate, but appreciate this is not something you can arrange quickly.

These accounts can then be used to receive BACS receipts from clubs as required.

RTTC National Championship: Team Time Trial – 30 May 2015

UK Anti-Doping (UKAD) has confirmed that Andrew Hastings, a member of the Richardsons – Trek RT team, which placed second in the above Championship, has been suspended from all sport for four years, from and including 30 May 2015, following an Anti-Doping Rule Violation. Andrew Hastings is disqualified from all events he has taken part in from and including the Team Time Trial National Championship held on 30 May 2015.

Andrew Hastings tested positive for two analbolic steroids; metenolone, its metabolite and a metabolite of stanozolol. The findings came as a result of an in-competition test at the Championship.

The Richardsons – Trek RT team, of which Andrew Hastings was a member, has been disqualified from the Championship, and will forfeit its second placing.
