# **District Council meeting to instruct National Council delegates**

During the week commencing Monday 9 November 2015 three copies of the National Council agenda will be dispatched to the secretary of each club then affiliated to CTT, one copy will be dispatched to all delegates attending the National Council meeting and one copy will be dispatched to all District Secretaries. This will satisfy the requirements of Article 17.

It is recommended that the District Council meeting to instruct delegates to the National Council meeting be held not later than Sunday 29 November 2015.

Details of amendments to be moved at the National Council meeting should be forwarded to the National Secretary (Legal & Corporate) to arrive not later than first post on Wednesday 2 December 2015, or if sent by email by 12 noon on that day. A summary of the amendments will be circulated at the National Council meeting.

#### **New Articles of Association**

As has been widely publicised, it is proposed that CTT adopts new Articles of Association. The adoption of the new Articles will be proposed and voted on at the National Council meeting 2015.

In the light of feedback received following the District Secretaries' meeting in June this year the voting procedure is to be simplified. There will be no requirement for affiliated clubs to formally nominate a "temporary" member of CTT. The procedure will be exactly the same as normally used at National Council meetings for any change to the Rules, Regulations or Articles in that a District's delegates to the National Council meeting will simply vote in accordance with the instructions given to those delegates by the District Council. (i.e. in accordance with current Article 10(b)).

A copy of the proposed new Articles will be sent to all affiliated clubs during September together with an explanation as to why the new Articles are proposed. That will give clubs sufficient time to consider the proposed new Articles and ask any questions should the club wish to.

# **Notification of Proposed members**

To be able to comply with the requirements of the proposed new Articles each District will need to nominate in advance of the National Council meeting that District's representatives who are to represent that District as members of CTT. Please can each District provide the name and address for each of its nominated representatives by Wednesday 2 December 2015.

Copied below is Article 5.2 of the proposed new Articles which sets out the number of representatives who may be admitted to membership of CTT on behalf of a District Council. This reflects the current Article 15.

a District Council having up to and including thirty affiliated clubs on 30 September in each calendar year shall be represented by a maximum of two members;

a District Council having between thirty one and forty-five (inclusive) affiliated clubs on 30 September in each calendar year shall be represented by a maximum of three members; and

a District Council having more than forty-five or more affiliated clubs on 30 September in each calendar year shall be represented by a maximum of four members.

and in the event of any District having a delegate appointed as Chairman such District shall be entitled to nominate a replacement member, in which case the Chairman will lose the right to vote, except that the Chairman has the right of a casting vote.

## **New/Updated Guidance Notes**

#### Amended affiliation/renewal form

At the 2014 National Council meeting a resolution was passed to the effect that the maximum amount that a club affiliated to CTT undertook to contribute towards any debts and liabilities of CTT in the event of CTT being wound up be reduced from £20 to £1. The affiliation/renewal form has been amended to reflect that change.

Please could the amended form (August 2015 version) be used for the purpose of the affiliations for 2016. The amended form is available on the CTT website and a copy accompanies this newsletter.

# **Appointment to the CTT Board of Directors**

Interested in standing for election?

The Board of Directors are elected each year at the National Council meeting. Although all the current directors are eligible to be re-elected, not all necessarily will stand for election. At this year's National Council meeting there will be at least one vacancy on the Board that will need to be filled.

To be eligible for election you must be a member of the current (i.e. this year's) National Council.
