[^0]Start on B5197 at last grid in LH gutter approx 35 yards before junction with Cunscough Lane ( A506).
Proceed to Cunscough Lane where LEFT and continue to Church Rd, Bickerstaffe where RIGHT with care.
Continue to Bickerstaffe Church, where bear LEFT into Intake Lane, then Lodge Lane to junction with A570 (island).(5.0m)
Turn LEFT with care and proceed along A570 via M58 island to Skelmersdale Island (6.98m).

Encircle the island with care and proceed SE along A570 via M58 Island and Lodge Lane Island to Rainford island (junction with B5203)(10.57m).
Encircle the island with care and proceed NW along A570 via Lodge Lane Island and M58 Island to Skelmersdale Island.(14.24m)
Encircle the island and proceed SE to Rainford island.(17.92m)
Encircle the island and proceed NW to Lodge Lane Island,(19.67m) where LEFT into Lodge Lane to Ben Lane, where LEFT along Ben Lane, through Barrow Nook then bear RIGHT up Hall Lane to Bickerstaffe Church, keeping Left along Church Rd to A506. (23.04m)

LEFT along A506 to FINISH at next to last grid in Gutter before John Hurst \& Sons Brookfield Farm on left (25.00m). (near gap in Hedge and before road on R with NO TRESPASSING sign).

RIDERS MUST EXERCISE EXTREME CARE AT RIGHT TURN IN CHURCH ROAD AND AT LODGE LANE / A570 JUNCTION WHERE OTHER RIDERS WILL BE APPROACHING FROM THE RIGHT.
