

V511 Course Info: Flat, long straight roads with only minor potholes and obstructions.

NB: Current restrictions on Bubwith Bridge, which results in the traffic lights now taking longer to change than was previously in place. Please take this into account when travelling to and from HQ by car and bike to reach the start line in due time!

#### \*\* there is a minor change to this course, see the cover sheet notes\*\*

START on south side of A163, approx. half mile west of Derwent Bridge (Bubwith), at western side of driveway to Derwent Cottage Farm (paint mark on road). PROCEED west, via North Duffield, South Duffield crossroads (2.04 mls) to Traffic Island at junction with A19 (Barlby north) – 4.24 mls. TURN LEFT (1st exit) and proceed south on A19 to Barlby South Traffic Island (junc. A63) – 5.15 mls. ENCIRCLE ISLAND (CARE!!) and retrace north on A19 to Barlby North T.I. – 6.16 mls. TURN RIGHT (2nd exit) on to A163, and proceed via South Duffield crossroads (8.40 mls), and North Duffield, to FINISH at mile stone "Selby 6, Weighton 12" on north side of A163, 580 yds before entrance to Duffield Cars car park – 10.00 mls



## **Key Points**

Please don't forget that both FRONT and REAR lights are required, it's a new regulation, you won't be able to ride the event without them.

The Start and Finish points have been advanced approximately 200ft, the new positions are clearly marked on the road. This is to avoid causing an obstruction to a Farm driveway. Please could riders not congregate across the Farm entrance as they queue up to start.

If you're under 18 at the time of the event please ensure you bring a signed CTT parental consent form otherwise you won't be able to participate in the TT.

We will post a copy of the CTT risk assessment for this course. If we find any further risks on the day we'll point these out as you sign-on at the event HQ

Baking and Tea/Coffee is provided by volunteers at the HQ, there is a nominal fee of £1 ,please remember to bring some change.

Please arrive at the HQ in good time to be able to sign on, pin on your number, warm up and head to the start. It's about 10minutes from the HQ to the Start.

Again NB: Current restrictions on Bubwith Bridge, which results in the traffic lights now taking longer to change than was previously in place.

Please take this into account when travelling to and from HQ by car

No "U turns" or warming up near the start line as this can be dangerous and interfere with the TT

Road Bike "non Aero" Category

and bike to reach the start line in due time!

For this category here's what is not allowed: TT bikes, Tri Bars, Disc Wheels, Tri Spoke Wheels and similar, Time Trial Helmets. Note however that deep section wheels are allowed provided they are below 60mm. Aero style road bike helmets are also allowed.

Please don't forget to return your number, it's important to sign-off after the event otherwise your result will not be valid!
