All competitors – please be aware of CTT Reg 14(i) No competitor shall be allowed to start unless such competitor has affixed to the rear of their machine a working rear red light and a working white front light, either flashing or constant, that are illuminated and in a position that is clearly visible to other road users. NO FRONT AND REAR LIGHTS– NO RIDE
